

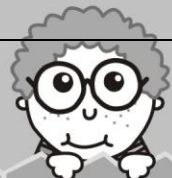
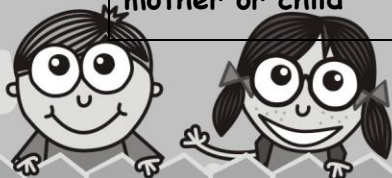

School fees that are paid in advance is not refundable.

- Notices:
